The leadership of Faith Deliverance International Ministries have made the decision to return to in-person services. These services will be held on Sundays between 11am and 1pm, until further notice. We intend to do so in a very safe manner in accordance with the Provincial and Municipal Place of Worship COVID guidelines.

In keeping with this, we have established the following Code of Conduct for Faith Deliverance International Ministries. These guidelines are intended to support our return to in-person services and to allow for individuals who choose to return to service to do so safely and guard against the transmission of COVID-19.

1. Individuals attending in-person services are required to wear mask at all times. The only exceptions are for persons who are not able to do so due to medical reasons or for children under the age of two (2).
2. All individuals must register online prior to attending a service. This is to effectively manage the number of individuals attending, and by extension, ensure we do not exceed the province's seating capacity and physical distance guidelines.
3. On entering the building, registration will be confirmed and every individual will be required to undergo a temperature check.
4. Individuals will be ushered to their seats after completing registration and temperature check.
5. There will be marked seating areas within the sanctuary and seating will be arranged so that physical distancing can be observed at all times.
6. Individuals from the same household or social circle may be seated together and should remain in place once they are seated.
7. Singing is a high-risk activity, hence, individuals should keep mask on even while they are singing. The only exception in this regard is the Praise and Worship team who will be at designated spots while ministering, and will be at an increased distance from the congregation.
8. The Minister who will be preaching/teaching the Word of God, will not be required to wear a mask while ministering as they will be at an increased distance from the congregation.
9. Microphones will not be shared; persons who will be participating in the services will be assigned their own microphones.
10. All physical contact, such as handshaking or passing of objects between individuals, should be avoided.
11. Any social interaction should involve physical distancing.
12. During the service, no time will be apportioned to collecting tithes and offering. Individuals are required to drop their tithes and offering in the designated box, upon exiting the building. Individuals not attending in-person services can continue to pay their tithes and offering as they have been doing previously.
13. One-way traffic flow will be implemented to promote physical distancing (i.e. enter through one door and exit through another).
14. Food and beverage service will be suspended at this time
